Thursday July 12-16, 2018

Attended AFT Convention 2018 in Pittsburgh, PA. See AFT Delegate Report.

Monday August 6, 2018

Attended *Meet and Greet With Bob Morgan and Julie Morrison* in Highland Park. Spoke with both Morgan and Morrison. Both support legislation that allows those who are 18+ years of age with special needs to be placed on missing list similar to children rather than police districts treating them in the same manner as adults. Much of the focus was on healthcare. Morrison advocates shutting down inadequate healthcare facilities but offered no alternative. Both support 3% salary increase limit for educators. Morrison stated Tier I teacher pensions remain an ongoing issue negatively impacting availability of funding for other needed public services.

Tuesday August 14, 2018

Attended *Meet and Greet With Daniel and Adam Didech* in Glenview. Spoke with both Daniel (IL State Rep., 59th District – challenger) and Adam Didech (Lake County Board, District 20 – challenger). Also spoke with Julie Simpson, Candidate for Lake County Board - District 18.

Daniel Didech's priorities include:

- lowering taxes for the middle class
- protecting women's right to choose by fully funding Planned Parenthood along with breast cancer screenings and reproductive healthcare
- fighting the "Trump Agenda"
- gun safety supports commonsense gun laws including universal background checks, a ban on military-style assault rifles, a prohibition on devices used to make semi-automatic weapons work like fully automatic weapons, and state licensing requirement for all gun dealers in IL
- government reform supports independently drawn legislative maps, proposals that would get money out of politics, elimination of the office of Lieutenant Governor, and consolidation of the offices of Treasurer and Comptroller

ELECTION NEWS

Lake County Board District 18

Lake County Board Chairman Aaron Lawlor announced he would be taking a 30-day leave for treatment of an addiction to an undisclosed drug. He represents Lake County Board District 18, which includes all of Vernon Hills and Indian Creek, as well as portions of Hawthorn Woods, Long Grove, Mundelein and unincorporated Lake County. Lawlor has entered rehab at a Hazelden Betty Ford Foundation Treatment Center.

Lawlor's political fundraising committee, Citizens to Elect Aaron Lawlor, was terminated by the state Board of Elections for failure to make required filings and to respond to a letter from the Board of Elections regarding this delinquency for 12 months. An outstanding fine of \$15,000 for

delinquent filing of required reports remains in force, and any successor political committees for the same candidate would be liable for the fine.

Lawlor was found to owe \$4,770 to Capital One Bank USA in a small claims court tort case. The judgment finding in favor of the bank was dated July 23, and the status of the case is now listed as closed. He was also named in a residential foreclosure case with MB Financial, which is now closed, from January of this year.

After learning that there were serious concerns about purchases made on Lawlor's procurement card over the last several months, Board members requested the State's Attorney's Office to conduct a special investigation. Using a procurement card for personal purchases is against the law, even if the purchases are reimbursed, as it is the unlawful use of taxpayer dollars. In this instance, there are questions regarding why it went on for so long, the approval process of those expenditures, and how much has been repaid to the County. The State's Attorney's Office called in an independent third-party organization to conduct a complete investigation.

An objection will likely be made regarding Lawlor's eligibility to run in the upcoming Gubernatorial Election. No alternative republican candidate has yet been named.

IL 51st Representative District

Incumbent *IL Rep. Nick Sauer* has withdrawn as state house candidate after sex scandal. The 51st District includes southern and central Lake County and a small area in Cook County. Sauer was publicly accused of "catfishing" other men by posting nude photos of an ex-girlfriend on a fake Instagram account and luring men into graphic discussions.

Republican officials have until Aug. 23 to name a candidate for the election. They also have 30 days from the day Sauer resigned to choose someone to replace him in the state House and finish his term, which expires in early January.

Sauer previously served on the Lake County Board and the Barrington Unit School District 220 board. He was also a member of the House Sexual Discrimination and Harassment Task Force.

Illinois Gov. Bruce Rauner called for Sauer's resignation and also sought to blame Madigan for fostering an inappropriate environment. Sen. Melinda Bush, co-chair of the Senate's harassment task force stated that if the allegations are true, it "goes beyond harassment" and crosses the line into "predatory and criminal areas." Bush, helped craft the "revenge porn" legislation. Under Illinois law, it's a felony to disseminate "private sexual images" without a person's consent.

 - Sponsored HB 175 in 2015 to allow people to report a possible violation of the act within 60 days of its discovery, rather than 60 days from the date of the meeting.

- Supports term limits Sponsor of HJRCA 11 that would limit General Assembly members to serving a maximum of eight years.

 Ban red light cameras - Sponsored HB 173 to ban red light cameras in non-home rule communities
