Come Stand In Solidarity With Rail Workers' Union

Come stand in solidarity with our brothers and sisters of the Rail Workers' Union at the United Auto Workers' Hall in Lincolnshire beginning at 7p. Bruce Campbell, author of *The Lac-Megantic Rail Disaster: Public Betrayal, Justice Denied* will be speaking about one of the most deadliest railways disasters in Canadian history. Members of the Rail Workers' Union will share their stories regarding their unsafe working conditions, and I (*Gerri Songer*) will be discussing the local impact and the need for school personnel to be included in comprehensive oil spill response plans, so they are able to effectively manage incidents involving hazardous material.

U.S. Transportation Department recently issued final rules requiring railroads to develop oil spill response plans and to disclose details of shipments to states and tribal governments after a series of high-profile incidents. Compliance with amendments adopted in this final rule is required beginning August 27, 2019.

Senate Bill 24, recently proposed by *IL Sen. Terry Link*, would require freight trains to be operated by a crew of at least two individuals until a federal rule or law is adopted that addresses how many crew members should operate a freight train.

Currently, there are several major rail projects underway, the Amtrak Hiawatha proposal, CREATE, and the Union Pacific Metra West Line. *US Rep. Brad Schneider* spoke out against the Amtrak Hiawatha proposal during a town hall meeting in Glenview addressing a crowd of more than 1,000 concerned residents.
