Highlight

The IFT is advocating for the Workers' Rights Amendment (WRA) to pass in November. The WRA - formally known as Senate Joint Resolution Constitutional Amendment 11 - would amend the Illinois Constitution to guarantee the fundamental rights of workers to unionize and collectively bargain.

Saturday March 12, 2022

Attended Local 1211 Legislative Breakfast in Palatine at the Cotillion Banquets. Legislator attendees included: Congressman Raja Krishnamoorthi, Sen. Laura Murphy, Sen. Ann Gillespie, Rep. Mark Walker, Rep. Michelle Mussman, and Rep. Terra Costa Howard. IFT President Dan Montgomery and IFT Legislative Director Dave Comerford from Springfield both attended. Local 1211 founder, John Braglia was honored. The Local 1211 office will now be called, "The John Braglia Center" to commemorate his achievements. Topics discussed included: Tier 2 pensions and pension reform, SEL and mental health funding, disinformation in the school communities, CTE expansion and other state mandates, education funding and the impact of TIF districts, new revenue enhancements, and workers' rights amendment in IL.

Thursday March 17, 2022

Attended Township H.S. Dist. 214 Board of Education meeting. A recognition ceremony was held to honor District Service and Student Excellence.

Saturday March 26, 2022

Attended Mary-Oke in Grayslake, a fundraiser in support of State Senate, 31st District Candidate Mary Edly-Allen. Volunteered to help canvass and write postcards. Former IL Rep. Edly-Allen

will run against Rep. Sam Yingling in the June 2022 Primary election to face Republican Adam Solando in the General election.

Other Lake County challenges include Senate District 26, in which incumbent, Senator Dan McConchie, will face democratic challenger, Candidate Maria Peterson, an attorney from North Barrington. In the 52nd House District, incumbent Rep. Martin McLaughlin, a Barrington Hills Republican, will face Mary Morgan of Island Lake. Morgan works in the curriculum and instruction office for Wauconda Unit District 118.

Wednesday-Thursday, April 6-7, 2022

Attended Lobby Days in Springfield. Legislation highlighted in Springfield by IFT Legislative Director, Dave Comerford, was Senate Bill 2298 TIF and PTELL Reform. This bill will allow local school districts to participate in decision-making rather than allowing municipalities to have exclusive authority over decision-making process.

Dave Comerford confirmed that unfunded liability for the five Illinois State pension systems, has reached \$140B. TRS comprises \$4.5B of this liability and is currently 45% funded. Illinois retirement systems include: State Employees' Retirement System (SERS), State Universities Retirement System (SURS), Judges' Retirement System (JRS), General Assembly Retirement System (GARS) and Teachers' Retirement System (TRS).
